How to submit a claim

How do I submit an Accident claim?

You can submit your request for Accident benefits online, or by email, fax or mail. You must complete all required claims forms in order for your claim to be considered for Sun Life's approval. For email, fax or mail submissions, these forms are located on the myMGM site. To submit your claim online, register and log into your Sun Life account.

Visit: myMGM and click under the Sun Life benefits section to be directed to the forms and Sun Life account login for online submissions.

When submitting a claim online, simply login to your Sun Life account and click, "Submit a claim." You will be guided through the submission process.

For email, fax and mail submissions, complete and print the Accident form, including the authorizations and Attending Physician Statement. (In addition to these forms, you may also include supporting medical documentation such as the Explanation of Benefits or Emergency Room Report).

How do I submit a Preventive Screening Benefit claim?

You can submit a claim online through your Sun Life account, or by calling 866-747-0370 and providing:

- Name
- · Date of Birth
- · Social Security Number
- · Date of exam
- Type of exam
