We are pleased to provide you with information regarding your application or claim. This information is provided to you in accordance with legislation enacted in your state. You may also receive other privacy notices from us or from our affiliated companies. **Please keep this notice and a copy of the completed application or claim form for your records.**

Our Underwriting Procedures

For certain types of coverage, we underwrite your request to determine if you are eligible for the coverage you requested. We review all of the information in the application, and, if necessary, confirm or add to this information in the ways described in this notice. In the event of an adverse underwriting decision, we will provide you with the specific reason for the decision in writing.

Privacy and Information Practices

Collecting Information

Your application or claim form is our main source of information. But we may:

- Ask you to have a physical exam, an EKG and/or a blood profile, etc.
- Ask physicians, hospitals, or other health care providers to confirm or add to the information you have given us. The types of information we may ask for are described on the authorization form you will be asked to sign. If you want a copy of this form, it will be given to you for your records.
- Obtain information from MIB, Inc., formerly known as the Medical Information Bureau. See “Notice Regarding MIB, Inc.” below.
- Seek information from other companies you have applied to for insurance.
- Ask you for additional information through use of a written request.

Notice Regarding Consumer Reports

Insurance companies commonly ask an outside source to verify and add to the information given in an application. Consumer reports are used to help us decide if you are eligible for the insurance you have applied for. The report deals with your mode of living, character, general reputation, and such personal items as your health, job, and finances. It may include information on the following: your marital status, past and present employment record, job duties, driving record, avocation, health history, use of alcohol and drugs, and hazardous sports activities. The agency may get information in these ways: from public records, and by contacting you, members of your family, business associates and employers, financial sources, friends, or others you know. This information will not be used to determine your sexual orientation. You can request that the agency interview you in connection with the preparation of the report. If the report affects your application as requested, we will notify you and provide you with the name and address of the reporting firm.

We use the report only to be sure that each application is evaluated on a fair basis. We will not reveal any of the information we obtain to your friends or associates. We may reveal the information we obtain to other companies or entities affiliated with us. The information may be kept by the consumer reporting agency; it may also later be given to others who have a legitimate need for these reports. It will be given only to the extent permitted by these laws: the Federal Fair Credit Reporting Act as amended by the Consumer Credit Reporting Reform Act of 1996; your state’s Fair Credit Reporting Act, if any; or your state’s Insurance Information and Privacy Protection Act, if any. If you wish, we will send you the name, address and phone number of any agency we ask to prepare a consumer report about you. The agency will give you a copy of the report if you ask for one and give proper identification.

Information Use

We will use the information only for business purposes arising from the relationship you have with us.

Information Maintenance and Disclosure

We treat the information we have about you as confidential. The authorization form that you have been asked to complete will permit us to send the information to our affiliates and to MIB, our reinsurers, employees, contractors, or other organizations that process transactions concerning coverage you have with us or our affiliates, and to other life insurance companies to whom you may apply for life or health insurance or to whom a claim for benefits may be submitted. In certain circumstances, the information we have about you may be disclosed to third parties without your specific permission.

Access to Information

If you request it in writing, we will send you a copy of the relevant information we obtain about you in connection with your request for coverage or an adverse underwriting decision. Medical information, however, will only be disclosed through the attending licensed physician unless state law provides otherwise. If you feel that any of the information in our file is not correct or is incomplete, we will review it. If we agree with you, we will make the corrections. If we do not agree with you, you may file a short statement of dispute with us. Your statement will be included any time we disclose this information to anyone. We will not send you information we collect in expectation of or in connection with any claim or civil or criminal proceeding.

Notice Regarding MIB, Inc.

We or our reinsurers may make brief reports to MIB. The reports will include the factors that affect the insurability of any person for whom coverage is being requested. MIB is a nonprofit organization of life insurance companies. It operates an information exchange for its members. If you apply to some other member company for life or health coverage, or send in a claim for benefits, MIB may supply that company with any information in its file. If you ask, MIB will arrange to disclose to you the information it has about you in its file. If you question the accuracy of the information in MIB’s file, you may contact MIB and ask them to correct it as provided in the Fair Credit Reporting Act. You certainly understand the importance of having sufficient life insurance. Now, you have an opportunity to make sure that you have the amount of coverage needed. Your loved ones will appreciate the peace of mind this Plan provides, with benefits up to \$1,000,000 that will let them go on with their lives with fewer financial concerns.

About This Plan

You may select from \$100,000 up to \$1,000,000 in 20-Year Life insurance coverage (in \$5,000 increments). Coverage continues as long as you remain an active member of the Minnesota State Bar Association, pay your premium when due; and the Group Policy remains in force. Your amount of coverage will not decrease due to age during a level term rate period.

For members or spouses or domestic partners who are under age 70 at the end of a level term period, coverage will not reduce until age 70. Member coverage will reduce to the lesser of 50 percent of the amount in effect prior to age 70 or \$50,000. Spouse or domestic partner coverage terminates at age 70.

Eligibility

All MSBA members under age 51 may apply for coverage for themselves, their spouse or domestic partner under age 51 and all unmarried dependent children ages 14 days through 19 years (23 if a full-time student).

A dependent who is also a member is eligible for either member or dependent coverage, but not both. If both member and spouse are covered as members, neither may insure the other as spouse/domestic partner and only one may insure any eligible children.

This coverage is available only for residents of the United States.

PLAN FEATURES

Pay Less if You're a Qualified Non-Tobacco User

Non-tobacco users meeting the highest underwriting standards may qualify for the Plan's lowest rates.

Satisfaction Guaranteed

You may return your Certificate of Insurance within 30 days if you are not completely satisfied with the coverage this Plan provides. Any premiums paid will be fully refunded, provided no claims have been submitted or paid.

Convenient Payment Options

You will automatically be billed on a semiannual basis. However, there are other payment options available. You can choose from quarterly direct billing, annual direct billing or automatic monthly check withdrawal.

Beneficiary Selection

You may name anyone you wish as the beneficiary of this insurance, and you may change the beneficiary by contacting the Insurance Administrator in writing and advising them of the change.

You may also choose to name a beneficiary that you cannot change without his or her consent. This is an irrevocable beneficiary.

Continuing Insurance After the 20-Year Term Ends

Premiums are designed to remain level for the first 20 years of coverage.* At the end of the 20-year period, if you still meet the requirements of eligibility, you may apply for re-entry. A written application and proof of good health satisfactory to ReliaStar Life is required.

If evidence of insurability is not provided or not approved by ReliaStar Life, rates will be based on the five-year age brackets for the insured's current age.

*The initial premium will not change for the first twenty years unless the insurance company exercises its right to change premium rates for all insureds covered under the group policy with 60 days advance written notice.

Effective Date

Your insurance will become effective on the later of the following dates:

- ReliaStar Life approves your proof of good health;
- Your premium is received;
- You become eligible for insurance; or
- You apply for insurance, if proof of good health is not required.

When Coverage Ends

Your insurance stops on the earliest of the following dates:

- The last day of the month during which you are no longer eligible for insurance under the Group Policy
- If you are not totally disabled, the date the Group Policy terminates.
- If you are totally disabled, the date ReliaStar Life stops waiving premiums under the Waiver of Life Insurance Premium Disability Benefit.
- The end of the period for which you paid premiums, if you do not make the next required premium contribution when due.

OTHER IMPORTANT INFORMATION**Accelerated Life Benefit**

The Accelerated Life Benefit option is available to help terminally ill insureds during a difficult, and often financially challenging, time. Under this provision, you may request one advance payment equal to 50% of your (or your insured dependent's) in force life insurance, or \$50,000, whichever is less, to be paid while the terminally ill person is still alive. You must have at least \$20,000 in Life Insurance coverage in force to qualify for this benefit. The amount of insurance payable after the insured's death will be reduced by this payment. Premium contributions will not be reduced.

This money can be used to help cover high prescription drug costs ... medical bills ... outstanding debts ... to help pay for experimental treatments ... the cost of modifications to your home ... or for a family vacation - the choice is yours.

To qualify, a terminally ill insured must provide ReliaStar Life with a doctor's statement which gives the diagnosis of your medical condition and states you have a life expectancy of no more than six months. For additional details and limitations, please see the Certificate of Insurance.

Please note that receipt of the accelerated benefit may be taxable, or may adversely affect your eligibility for Medicaid or other government benefits. You should consult your personal tax advisor to assess the impact of this benefit.

Accidental Death & Dismemberment Insurance (Optional)

Group Accidental Death & Dismemberment (AD&D) Insurance can be elected up to the same amount of death benefit for which you may be applying. In addition, many people are seriously injured by accidents and sustain loss of limb or eyesight. For these reasons, MSBA Group Accidental Death & Dismemberment (AD&D) Insurance is an important addition to your benefit plan.

Waiver of Life Insurance Premium Disability Benefit

You pay no premiums if you become totally disabled as defined in the certificate. Your coverage will continue at no cost to you if you become continuously totally disabled for at least six consecutive months and if your disability occurs before age 60.

Employee Coverage Available

Employees of MSBA members who are under age 51 may also apply for 20-Year Level Term Life Insurance through ReliaStar Life. Employees may select from \$100,000 to \$250,000 of coverage (in increments of \$5,000).

In order for an employee to be covered, the employee must be eligible for the insurance, be actively at work, and be able to give ReliaStar Life acceptable proof good health if requested.

Employees that are approved for coverage will receive the Accelerated Life Benefit, Accidental Death & Dismemberment Insurance option and the waiver of Life Insurance premium disability benefit. Please see the Certificate for details.

Coverage for employees reduces to 65 percent of the original amount at age 65, to 50 percent of original face amount at age 70, and to 30 percent of original face amount at age 75. Coverage terminates when the employee is no longer actively employed by the member.
